

**CITY OF ADAMSVILLE, ALABAMA
ORDINANCE 2011-04
ANNEXATION**

WHEREAS, on the 11th Day of April, 2011;

Margy Ruth & Billy H Thompson

Being the owners of all the real property hereinafter described, did file with the City Clerk a petition asking that the said tracts or parcels of land be annexed to and become a part of the City of Adamsville; and,

WHEREAS, said petition did contain the signatures of all of the owners of the described property and a map of said property showing its relationship to the corporate limits of the City of Adamsville; and,

WHEREAS, the governing body did determine that it is in the public interest that said property be annexed to the City of Adamsville and it did further determine that all legal requirements for annexing said real property have been met pursuant to Section 11-42-20 through 11-42-24, Code of Alabama, 1975;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ADAMSVILLE, ALABAMA, AS FOLLOWS:

Section 1. The Council of the City of Adamsville, Alabama finds and declares as the legislative body of the City that it is in the best interests of the citizens of the City, and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the City of Adamsville.

Section 2. The boundary lines of the City of Adamsville, Alabama, be, and the same are hereby altered or rearranged so as to include all of the territory hereto before encompassed by the corporate limits of the City of Adamsville, Alabama, and in addition thereto the following described territory, to wit:

“Exhibit A”

Section 3. The zoning of the property described on “Exhibit A” attached hereto will convert to the City of Adamsville, Alabama most compatible zoning classification, pursuant to the current zoning ordinance.

Section 4. This ordinance shall be published as provided by law, and a certified copy of same, together with a certified copy of the petition of the property owners, shall be filed with the Probate Judge of Jefferson County, Alabama.

Section 5. The territory described in this ordinance shall become a part of the corporate limits of Adamsville, Alabama upon publication of this ordinance as set forth in Section 4, above.
