**WHEREAS**, in the 2008 City of Adamsville Municipal Election, Tammy Abston qualified and was elected for City Council District 3; and

**WHEREAS**, on September 2, 2008, the City Council adopted Resolution Number 2008-35, Certificate of Election to Tammy Abston, District 3, Adamsville City Council; and

**WHEREAS**, on June 13, 2011, Tammy Abston tendered her resignation from the Adamsville City Council; and

**WHEREAS**, Section 11-43-41, Code of Alabama, 1975, requires that the vacancy of District 3 be filled by the City Council; and

**WHEREAS**, the City Council received applications from individuals interested in filling the unexpired term of Mrs. Abston; and

**WHEREAS**, the Council reviewed said applications and determined it would be in the best public interest to appoint Mr. Richard G. (Glen) Minyard to fill the unexpired term of Tammy Abston, District 3.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
THE CITY OF ADAMSVILLE , ALABAMA, AS FOLLOWS:**

1. Mr. Glen Minyard was hereby appointed on July 18, 2011 to fill the unexpired term of Tammy Abston, District 3; and
2. Said Resolution Number 2011-19 declares the actions taken by the City Council of the City of Adamsville on July 18, 2011 affirming the appointment by the City Council of Adamsville.
